8:45 - 9:45am Scientific Approaches to Creating Change: Reducing Bias, Creating Inclusion, and Promoting Equity

Hosted by Dr. William T. L. Cox, a stereotyping and bias reduction researcher from the University of Wisconsin-Madison and the CEO of the Inequity Agents of Change nonprofit. In his hour-long session, Dr. Cox will provide an introduction to the bias habit-breaking training, which is the only bias/diversity training that has been experimentally tested and shown to be effective at creating meaningful changes related to bias, diversity, and inclusion. Dr. Cox will share insights into understanding how to reduce bias related to race, gender, and other social identities, drawn from his and his colleagues' 15 years of research on the bias habit-breaking training. 10:00 - 12:00pm The Truth Behind Lying - Part 1

Typically, a presentation on lying includes watching slow motion video aimed to put a spotlight on "micro facial expressions" as a way of detecting deception. While these types of presentations may be entertaining, the reality is, even seasoned negotiators and interrogators have a hard time effectively employing those strategies consistently or with any degree of certainty. CTK Group is a team of active investigative interviewers who train law enforcement officers, insurance adjustors and attorneys on "best practice" techniques for deception detection. Hosted by Jon Turbett, Special Investigator with the Iowa Division of Criminal Investigation, Jon oversees the legal component of The CTK Group's interview and Interrogation courses. This session will put a spotlight on what actually and consistently produces results based on current research. While the discussion will be through the lens of a criminal investigator, it will provide practical application to advance the skills of experienced mediators/arbitrators. It is aimed to reveal the truth behind lying. Both sessions are set to be an open forum, so questions are encouraged throughout the presentation.
